 - b. authorised under paragraph 3(d) of the Consular Fees Act 1955, and
 - c. exercising his or her function in that place
- \circ employee of the Commonwealth who is:
 - a. in a country or place outside Australia, and
 - b. authorised under paragraph 3(c) of the Consular Fees Act 1955, and
 - c. exercising his or her function in that place
- engineer who is:
 - a. a member of Engineers Australia, other than at the grade of student, or
 - b. a Registered Professional Engineer of Professionals Australia, or
 - c. registered as an engineer under a law of the Commonwealth, a state or territory, or
 - d. registered on the National Engineering Register by Engineers Australia
- o finance company officer with 5 or more years of continuous service
- o holder of a statutory office not specified in another item in this list
- o judge
- o Justice of the Peace
- o magistrate
- marriage celebrant registered under Subdivision C of Division 1 of Part IV of the *Marriage Act 1961*
- o master of a court
- o member of the Australian Defence Force who is:
 - a. an officer, or
 - b. a non-commissioned officer within the meaning of the *Defence Force Discipline Act 1982* with 5 or more years of continuous service, or
 - c. a warrant officer within the meaning of that Act

- o member of the Australasian Institute of Mining and Metallurgy

 - a. the parliament of the Commonwealth, or
 - b. the parliament of a state; or

 - a. the Commonwealth, and

 - a. a state or territory, or a state or territory authority, or
 - b. a local government authority with 5 or more years of continuous service, other than such an employee who is specified in another item of this Part
- person before whom a statutory declaration may be made under the law of the state or territory in which the declaration is made
